**IMPORTANT NOTES:**

**Insurance requirement:** General liability insurance with a limit of not less than \$1,000,000 (some types of vendors may require a higher limit) for each occurrence written by an insurance company authorized to conduct business in the State of Washington. The vendor shall be named insured, as well as the "Cowlitz County Fair & Thunder Mountain Pro Rodeo, its' Officers, Directors, Agents and employees" shall be named as additionally insured. Certificate of Insurance MUST be on file not later than June 1, 2021. Vendors may use their own policies or be added through a rider on the Cowlitz County Fairs' policy.

I need to purchase an insurance rider on the Cowlitz County Fair policy (\$150 per contracted space)

Commercial vendors must meet all requirements established by the Cowlitz County Health Department, the City of Longview Fire Marshal, and the Cowlitz County Risk Manager.

No food will be allowed as a handout from non-food commercial booth spaces. Some samples may be allowed, but must be approved by the fair management prior to the fair. No coffee makers, portable heaters or like appliances are permitted in commercial vendor spaces.

No pets are allowed on the grounds (including campground), with the exception of service animals.

No tents or overhead canopies are allowed in the indoor vendor area as directed by the City of Longview Fire Marshal. The Cowlitz County Fair is unable to rent tables, chairs, skirting, etc.
