IMPORTANT NOTES:

Insurance requirement: General liability insurance with a limit of not less than \$1,000,000. General Aggregate insurance with a limit of not less than 2,000,000. (Some types of vendors may require a higher limit) for each occurrence written by an insurance company authorized to conduct business in the State of Washington. The vendor shall be named insured, as well as the "Cowlitz County Fair & Thunder Mountain Pro Rodeo, its' Officers, Directors, Agents and employees" shall be named as additionally insured. Certificate of Insurance MUST be on file not later than **June 1, 2023**. Vendors may use their own policies or be added through a rider on the Cowlitz County Fairs' policy.

Commercial vendors must meet all requirements established by the Cowlitz County Health Department, the City of Longview Fire Marshal, and the Cowlitz County Risk Manager.

No pets are allowed on the grounds (including campground) with the exception of service animals.
